

& Member Education

"To the Greeks therefore, and not to the Romans, we are indebted for what is great, judicious and distinct in architecture." This assertion is part of the Fellow Craft

lecture's instruction about the five orders. What should we make of it? Is it really important to know the details and differences of the five kinds of columns?

Two things (at least) come to mind. First, architecture—the building of columns, pilasters and Temples—is a metaphor. A metaphor asserting we're here to build (our) character and improve ourselves so that we can be contributing members of society. We can pick a column, study its structure and details, what it is and how it differs from the others. We can then think symbolically about what we've learned and apply it to our conduct and life. It is doubtful that our ancient brethren really thought it was important to know the literal difference between Doric and Ionic columns—perhaps our task is to examine their distinctions symbolically?

Secondly, what do we make of the contrast between the Greeks and Romans? We are indebted to the Romans for many things. Indeed, the 30th Degree reminds us of their virtue, civic commitment and virtu (ability and character).

Our ancient brethren may be reminding us that the foundation and history of western intellectual thought began with the Greeks. It is remarkable that it is so. Greece is a small country; its economy was nothing special compared to say, the Pharaohs' in Egypt. Other countries had good armies and navies, conducted trade, built equally monolithic structures; Greeks were no more nor less religiously inclined than any other people. Yet it was Greek culture that produced Pythagoras around the 6th century BCE, Parmenides in the 5th and then Plato, Aristotle, and many others thereafter. The Greeks seemed to have "invented" philosophy—the pursuit of wisdom.

We indeed have much to learn from the Romans, but the Greeks seemed to have been the first to make us to think, to encourage us, by example, to learn, question, examine, contemplate and search for Truth.

Greek and Hellenic thought appears in many places in our ritual—our ancient brethren saw to that. Perhaps this one line of the Fellow Craft lecture indicates that our journey in search of Light and Wisdom begins with, and will call heavily upon, Greek thought and philosophy. We are indeed indebted to Greeks.

Our next Reunion is October 29 and November 5. The 16th Degree, Prince of Jerusalem, returns. It has been at least ten years since it was last conferred. Notably, the 16th through the 18th Degrees will be conferred in succession—an excellent opportunity for comparing and contrasting the lessons of these Degrees. The Reunion schedule appears elsewhere in this Bulletin.

We still have Council Degrees in need of Degree Masters and teams. Brethren interested in degree work or becoming a Degree Master can contact me at dow@srtampa.org. Our hope is to have ritual teams for all 29 Degrees for 2017.



Almoner by Coleman L. Hill, 32° KCCH

Brethren, periodically, it is necessary to address you on behalf of the Almoner's Fund. However, there has never been a more important time than this moment.

As many of you are

aware, the role of the Almoner's Fund has changed over the past few years. Rather than assisting only the members of the Scottish Rite, we have attempted to meet the needs of all Masons and their families, as well as the needs of the community. The result of this has been a larger awareness of our fraternity, specifically the Scottish Rite, and the various charitable efforts associated with Freemasonry.

The guiding rule for the Almoner Fund has been that the individual or family receiving our charity must acknowledge that it is a single offer of assistance; they must offer credible evidence that they will be self-sustaining henceforward and, if possible, any funds advanced will be repaid. Generally speaking, those needing assistance have been temporarily unemployed due to layoffs, seasonal employment, or health reasons.

In the past we have paid back rent, mortgage payments, utility bills, and, in one extreme instance, the cremation of the child. Due to your generous contributions, we have been able to maintain a fairly stable balance of between \$5,000 and \$7,000.

The past several months, however, have strained our resources beyond any situation within recent memory. In addition to anticipated monthly donations, we have had two brothers who have experienced devastating losses. In one case, the brother and his wife went to a Masonic meeting. When they returned, their entire residence had burned to the ground. Furniture, clothing, items associated with more than 60 years of memories—irreplaceable and irrevocably gone. They were left with clothes they wore, the car they drove, and (ironically) the Masonic apron appropriate to the event they had just attended.

Brethren we have dispensed more than \$5,000 in the last 60 days; additionally, we committed ourselves to a further \$2,000. In simple terms, we are not only broke; we are in debt as a result of our efforts to meet the charitable needs of those who desperately need our help.

As I have previously indicated, charity is a cardinal part of nearly every obligation we have sworn to uphold as a condition of our membership the various Masonic bodies to which we belong. Our present situation offers perhaps the most dramatic test of our commitment to those obligations. I appeal to you, not just as the Almoner, but as a Brother and as one who has previously received assistance from our fraternity, see how deeply you can reach to assist those in need.

Those of us who work with charitable organizations are frequently in contact with each other. At this time, most charities, which I am aware, are hurting. Many are seeking charitable labor in the lieu of contributions; this is an awareness of how tight money is these days. However, there is no substitute for monetary contributions and no substitute for monetary needs.

Be generous, Brethren. When the time comes to be judged by the Great Architect, you will not be judged on the quality of your ritual, you will not be judged on your regular attendance, you will not be judged by the times you have signed as top line on a petition. All of these and more will be secondary to your efforts on behalf of your fellow man. Think about it... Can you, will you help your fellow man? Only you can answer that question. Only the Great Architect can judge the appropriateness of your response.

So mote it be.
