# About the Scottish Rite Foundation of Florida, Inc.

In the early 1950's in Colorado, the Scottish Rite of Freemasonry of the Southern Jurisdiction of the United States initiated a program to help children with speech and language disorders. The results obtained from this program led to the establishment of RiteCare Scottish Rite Childhood Language Program clinics to provide diagnostic evaluation and treatment of speech and language disorders, as well as learning disabilities.

In 1962 the Scottish Rite Foundation of Florida, Inc. was established as an expansion of the efforts of the Scottish Rite of Freemasonry. Today, our Florida Foundation funds childhood language therapy in fourteen clinics operated by hospitals and private practitioners. There are currently six clinics within the Valley of Tampa that the Foundation supports. These clinics are in Brandon, Lakeland, New Port Richey, Sarasota, St. Petersburg and Tampa. The Foundation provides funds to ensure that no child is unable to receive treatment for a language disorder because of an inability to pay.



The accomplishments since 1962 in Florida have been simple to list: to help children to hear, to speak and to understand. That is the goal of the Scottish Rite Foundation of Florida and that is what it has done. Starting off with a lesser number of clinics than the fourteen that the Foundation now supports, it has increased its support by establishing new clinics over the years and increased its public awareness and fundraising efforts. The Foundation's long-term goals include establishing additional clinics in more of Florida's grater metropolitan areas and setting aside funds for an endowment and long term operation.

Through the efforts of the Scottish Rite Masons of Florida, the Foundation has been able to not only help children, but also their families. Family members have been given the gift of hope: hope that their children will lead better lives; hope that they will be a family that hears their children speak, lead productive lives and say their name. Since 1962, the Foundation has been able to send millions of dollars from our members and other generous

#### **Special Event at our Fall Reunion**

On the first day of our Fall Reunion (October 20), Florida Knighthood will be holding their annual Cotillion at the Valley. Knighthood is an appendant body of the Order of DeMolay and its membership are generally our older DeMolays.

One of the events that is held at Cotillion is the conferral of the Initiatory and DeMolay Degrees on new members. With the assistance of our Director of Work, we have worked the conferral of the DeMolay Degree into our Reunion schedule. The Degree is scheduled for 2:45 p.m. and will be open to all Master Masons attending the Reunion. There will not be a conflict with our Scottish Rite Degrees so everyone will be able to witness the trials of Jacques DeMolay prior to his execution by the King of France.

The Order of DeMolay is currently in its Centennial year and will celebrate the Order's 100th birthday on March 18, 2019. The Scottish Rite has played an integral part in the Order's history as it was founded in Kansas City, Missouri by Brother Frank S. Land. Brother Land was employed by the Scottish Rite in Kansas City and Mother Chapter held their meetings at the Scottish Rite Masonic Center for many years.

Brethren, it is hoped that you will attend the first day of the Reunion and witness the DeMolay Degree.

#### The Feast of Tishri



The origin of the Feast of Tishri (also known as the Feast of the Tabernacle and/or The Feast of Succoth) is described in the Book of Leviticus. Chapter 23 of the Old Testament. "Also, in the fifteenth day of the seventh month, when ye shall have gathered in the fruit of the land, ye shall keep a feast unto the Lord seven days: on the first day shall be a sabbath, and on the eighth day shall be a sabbath. And ye shall take you on the first day the boughs of goodly trees, branches of palm trees, and the boughs of thick trees, and willows of the brook; and ye shall rejoice before the Lord your God seven days. And ye shall keep it a feast unto the Lord seven days in the year. It shall be a statute for ever in your generations: ye shall celebrate it in the seventh month. Ye shall dwell in booths seven days; all that are Israelites born shall dwell in booths." (Verses 39-42)

Hundreds of years later, after the completion of the Temple of Solomon, King Solomon delayed the dedication of the Temple until the Feast of Tishri, as described in II Chronicles 5: "Then Solomon assembled the elders of Israel, and all the heads of the tribes, the chief of the fathers of the children of Israel, unto Jerusalem, to bring up the Ark of the Covenant of the Lord out of the city of David, which is Zion. Wherefore all the men of Israel assembled themselves unto the King in the feast which was in the seventh month." (Verses 2-3)

Originally celebrated as a harvest and gathering festival, we now observe the Feast of Tishri because it is an age-old custom which now has the power of law; as under the Statutes of the Supreme Council, the feast is considered an obligatory observance, a sharing of our fraternal spirit.

# Member Education & Director of Work

Freemasonry offers many of its lessons through symbolism. Prominently, the working tools of the various degrees provide instruction. Not so obvious

sometimes are the symbolism of numbers; the number of candles, circumambulations, officers, etc. Sometimes a lesson is concealed within a color or movement or a small symbolic gesture.

In late July, the annual Tri-State Degrees were conferred in Warner Robins, Georgia. Alabama conferred the Entered Apprentice Degree, Florida the Fellowcraft Degree, and Georgia, the host, the Master Mason Degree. A symbolic gesture was observed during the Alabama and Georgia degrees that does not occur in our jurisdiction.

The first paragraph of the obligation is almost identical in all three jurisdictions. The movement and position of officers are similar. However, the Master in both the Alabama and Georgia, upon saying the word "hereon," placed his hand on top of the Candidate's. At the end of the first paragraph, the Master removed his hand.

A small gesture it was. However, it spurred several symbolic ideas. First, the placement of the Master's hand might focus the Candidate's attention on what is underneath his. That gesture, being timed with the word "hereon," reinforces that notion that obligation is sacred and is undertaken not only before the Craft, but under the eye of Deity. It might also reassure the Candidate he will have support during his journey—he does not travel alone.

The removal of the hand during the remainder of the obligation could signify that ensuing promises and commitments are the responsibility of the individual; the brethren will aid and assist, but action is necessary by the individual. The promises of the remaining paragraphs are personal. Initiative is a must.

The placement and removal of the Master's hand was a small symbolic gesture and was easy to miss. Nonetheless, it provoked thought and reflection. The Fall Reunion approaches. On day one, October 20, a special event is scheduled—the presentation of a DeMolay Degree. On day two, October 27, the 25th Degree, Knight of the Brazen Serpent will be conferred. This degree has not been conferred in our Valley for many years. The schedule is included elsewhere in the Bulletin. Please solicit candidates.

# Whatever Happened to Compassion?

Colossians 3:12 (NIV)

"Therefore, as God's chosen people, holy and dearly loved, clothe yourselves with compassion, kindness, humility, gentleness and patience."

Among the aspects central to the Christian faith is compassion. When we show love, care, and concern for the suffering and misfortune of others, we identify with Christ Himself. Jesus' life on earth was filled with compassion. During the time He lived and ministered among us, He consistently devoted His time to those who were hurting and in need. He healed diseases, fed the hungry, cast out demons and brought sight to the blind. He even raised the dead. His example reminds us to see and care about the needs of those around us.

This came as a shock to the religious leaders of the time. Many believed Jesus would arrive as a conquering hero, and would spend His time on earth with religious leaders. Yet we see in the Gospels that Jesus often shunned religious leaders and made a habit of connecting with people who today we would see as "on the fringes" of society. He cared about them, loved them, and met their physical and spiritual needs.

Perhaps the greatest need for our faith, our neighborhoods, and our nation today is compassion. In an increasingly polarized, world we find ourselves separated from one another more than ever before. Among the repercussions of this cultural shift is a lesser emphasis on having compassion for one another. Yet our needs as a people range from homelessness to hunger to difficulty making ends meet financially, to medical and health challenges, continue to grow.

The Church can and must respond to the needs of hurting people with compassion. The book of Colossians reminds us to be clothed in compassion, kindness and gentleness. When we see the needs of others and help to meet them with our resources without any regard to compensation or other benefits to ourselves then we reflect the image of Christ in our world. We will also open up avenues to share the Gospel with those we are able to serve.
