Member Education & Director of Work

The words and language of Masonic ritual often generate a trip to a dictionary. Superficies, cowan and inculcate might be good examples of additions to our

vocabulary after the first two degrees.

Some familiar words used in our ritual invite reflection. Their definition may be known, but their usage sometimes seems awkward or puzzling. Is there something more behind a familiar definition?

The Trowel is introduced in the 3rd Degree. Its symbolic explanation includes the language, "...no contention should ever exist, but that noble contention, or rather emulation, of who best..." (see full language in the *Monitor*.)

Modern definitions of emulation include "an ambition or endeavor to equal or excel over others' achievements..." Some friction can be detected between this modern definition and the Masonic instruction about the Trowel's symbolism.

Ambition and competition are not principles Masonry espouses or advocates. When choosing the word "emulation" in the ritual, what message did our ancient brethren seek to send?

Our ancient brethren may have selected the word "emulation" to compare or contrast it with the word "envy."

A sample of writings existing during the development of Freemasonry may help see a contrast. Chaucer (1343-1400 CE) considered envy the "worst sin ...against all virtues and against all goodness." Remember the ruffians in the 9th and 10th Degrees and the Hiramic Legend.

A Greek word often used for envy is *phthonos* and describes "a highly destructive emotion whose principal tendency is to destroy …the envied object or the rival."

The Greeks had another word for envy, *zelos*. Aristotle (384-322 BCE), held *zelos* to be a good passion, a form of positive envy, i.e., emulation. "Emulation ...is virtuous and a characteristic of virtuous men..." Adam Smith (1723-1790 CE) agreed: "emulation, the anxious desire that we ourselves should excel, is founded in our admiration of the excellence of others." David Hume (1711-1776 CE) praised emulation as "a spur to industriousness" and he refers to "noble emulation."

The writings of these sages were available to our ancient brethren and were no doubt read and studied. Perhaps our Brethren's instruction to "emulate" referred to *zelos*, a positive envy. Their message may have been for us to seek out admirable, virtuous, upright and just men as examples and role models, so that we might nobly contend *with ourselves* to become better men. Perhaps our ancient brethren direct us to identify eminence in others and to *emulate* it, not by "pulling others down, but by raising ourselves." This is a quite noble ambition.

Emulation, it seems, is a Masonic duty.

In any event, the words repeated in our ritual usually, if not always, contain some background message that is not easily conveyed by modern definition and interpretation. Reflection and study are warranted.

The Fruit of Patience

"Or do you show contempt for the riches of His kindness, forbearance and patience, not realizing that God's kindness is intended to lead you to repentance?" Romans 2:4 (KJV)



God described Himself to Moses as, "A compassionate and gracious God, slow to anger, abounding in love and faithfulness, maintaining love to thousands, and forgiving wickedness, rebellion and sin." And while He goes on to say that He will not leave sin unpunished, it is still His desire that none would perish, but everyone would come to repentance.

Have you ever wondered why God hasn't long since brought an end to the wickedness on this earth by sending Christ for His Bride, the Church? We see how He dealt with sinners in the days of Noah, and with the evil in Sodom and Gomorrah. Has God changed since those days? Has His hatred of sin dissipated? It cannot be so, for Numbers 23:19 teaches us, "God is not human, that He should lie, not a human being, that He should change His mind." So why does He tarry His return?

The answer is that He is patient—long suffering. His patience with rebellious sinners is an expression of His kindness, which is meant to lead the wayward to repentance. His patience has nothing to do with His anger towards sin, rather it is meant to woo the lost back to Him. Therefore, patience is at the core of who God is, and how He acts. Patience is not apathy or indifference. It is not weakness. On the contrary, His patience reveals His awesome power and His gentle kindness at the same time. Only God could choose to show such restraint in the midst of His wrath against sin.

So why is it important that we are patient with others? As believers, our purpose on this earth is to glorify Christ in all we do and say. This means that our behavior and attitude should give an accurate portrayal of our God. Our lives should be a reflection of Christ. When people see us, they see Jesus, not because we are so good, but because Christ in us is good.

The "fruit" of our lives should be spiritual, not carnal. We have been redeemed so that love, joy, peace, patience, kindness, goodness, faithfulness and self-control are born through us, drawing others to Christ.
