He was the first member to receive the Master Craftsman Award in the Valley in 2008. He has also served as a member of the Valley Executive Committee, a member of the Knights of St. Andrew and as the Chairman of the Double Eagle program. For his work and dedication, he was invested with the Rank and Dignity of a Knight Commander of the Court of Honour in 2009 and was coroneted a Thirty-third Degree Scottish Rite Mason in 2017.

Not being one to rest on his laurels, Ill. ∴ Gilmore has been very active in the various York Rite bodies in Florida, serving the Grand Commandery as Grand Commander in 1997 and M. ∴ I. ∴ Grand Master of the Grand Council of Florida in 2009. ## **Henry A. Echezabal, Jr., 32°**

### **Master of Kadosh**



Henry Echezabal is a life-long native of Tampa, who attended public schools and developed a passion for Education. Born in the heart of old, Ybor City's Latin culture, Henry's first language was Spanish. This was only natural as his mother's parents were from Spain, while his father's from Cuba. Henry grew up in the 60s to a normal, traditional upbringing doing all the ordinary things kids did back then. He participated in Little League baseball, attended YMCA, went to church and from the age of 8 practically dedicated his early life to the Boy Scouts of America—achieving the rank of Eagle Scout on November 11, 1970.

During many summer camps he learned numerous skills that would lead into later life, especially those related to the waterfront; he excelled in all areas of aquatics. As a result, he pursued competitive swimming in high school, SCUBA diving, enjoyed day-sailing and worked for seven summers for the City of Tampa Recreation Department - Pools. Throughout high school and college, he worked every job from locker boy to assistant pool manager. He was a life guard and head water safety instructor in charge of the swimming program at Jenkin's Pool on Davis Islands. During this time, he taught many of the swimming skills originally learned in Scouting to kids in the community.

Henry attended the University of South Florida where he graduated with Honors with degrees in Political Science and Secondary Social Science Education. He attended Nova University's Shepard Broad Law Center in Ft. Lauderdale, where he earned his Juris Doctor's Degree. After college, he worked for his father's surveying and mapping firm, Echezabal & Associates, and became a teacher for Hillsborough County Public Schools. Over the past 11 years, he specialized in the area of adult education, teaching every subject at every functioning level, to adult students in every walk of life.

Although his parents, Hope and Henry, Sr., have been involved in Masonry for the past 60 years, Henry

came to Masonry late in life, joining A.W. Windhorst Lodge No. 185, on May 5, 2004. He joined the Blue Lodge line immediately upon becoming a Master Mason, and became Worshipful Master in 2009. He has never left the lodge's officer line and has now served as treasurer for the past seven years. Over the last six years, he has had the great honor and pleasure of traveling with the District Deputy Grand Master as a Committeeman, and is currently serving as Child ID Chairman for the 20th Masonic District. He is a Member of the Zendah Grotto. And, finally, is greatly honored to be elected, Master of Kadosh of one of the most eminent Scottish Rite organizations in the Southern Jurisdiction, the Valley of Tampa. 🐼

## **Ill. Carl E. Gilmore, 33°**

### **Commander of the Council**



Ill. Carl E. Gilmore, 33° was elected to serve the Tampa Council of Kadosh as its Commander for the year 2020. Born in Massachusetts, his family moved and he was raised in Pompano Beach, FL. While attending Worcester Polytechnic Institute, Ill. Gilmore withdrew and served four years of active duty in the US Navy. Following his service, he returned to college and earned a degree in Civil Engineering and a Master of Building Construction Degree from the University of Florida in 1971. He opened his own civil engineering firm in the Tampa Bay region and retired in 2006. He continues to serve as a consultant in the engineering field.

He petitioned Tarpon Lodge No. 112 in 1972 and was Raised to the Sublime Degree of Master Mason in 1973. He served Tarpon Lodge as its Worshipful Master in 1977, the same year that he became a Master of the Royal Secret in the Valley of Tampa. His work and dedication to the Grand Lodge of Florida has not gone unnoticed as he was appointed DDGM of the then 19th District by M.: W.: Lynn P. Blich. He has also served on the Board of Trustees of the Masonic Home in 1986 & 1987 and again in 1998 & 1999.

## Member Education & Director of Work

Freemasonry is an exercise in the study of virtue. We begin early in the Blue Lodge, considering the four cardinal virtues, Fortitude, Temperance, Prudence and

Justice and the three theological virtues, Faith, Hope and Charity. Friendship, Morality and Truth are introduced later.

These might be termed “major” virtues. The Scottish Rite continues the exploration of what might be referred to as the “minor” virtues or, better, “foundational” virtues; those character traits that must be developed and acquired to develop the major ones.

Its 29 Degrees steadily present lists of desirable and necessary qualities or traits: silence, obedience, fidelity, industriousness, honesty, benevolence, devotion, civility, frankness, disinterestedness; the list is extensive. Indeed, in “Understanding Manhood in America,” Illustrious Robert Davis 33° GC, identifies 103 virtues taught in the degrees of Freemasonry.

Aristotle thought humans (like all creatures) were created to perform certain activities or series of actions with their souls, minds and bodies. He defined virtue as the “art of being a good human being.”

Aristotle counsels that virtue does not come to us naturally. We must use our rational abilities to identify virtuous action and then practice it until it becomes a habit

George Winfred Hervey (1821-1908), author of “The Principles of Courtesy, with Hints and Observations on Manners and Habits” agrees noting, “...one's own experience is less valuable to him than is commonly supposed. He seldom learns the lesson of experience till it is too late to reduce it practice.”

Further Hervey opines that it is an absurd pretention that anyone can “readily master any art without availing himself of the experience of his predecessors.” The “art of being virtuous” requires not only

practice (as Aristotle taught), but the consultation with our ancestors through the study of tradition, history, philosophy and religion.

His book focuses on foundational or minor virtues, as does the Scottish Rite. Each of its twenty-six chapters focuses one virtue, e.g. meekness, gratitude, deportment, zeal and hospitality.

Hervey teaches us 26 virtues; Freemasonry at least 103. Hervey has us look to our predecessors for knowledge and wisdom, as does the Fraternity. Aristotle would have us learn and practice the “art of being a good human being,” until virtue is indeed a habit.
