Scottish Rite Foundation of Florida

The Scottish Rite Foundation of Florida helps children with learning disabilities by supporting 14 clinics located throughout the entire state of Florida. It depends upon donations made by corporations and individuals, most of whom are members of the Scottish Rite, their families, or friends.

The current annual commitment made to these clinics is \$330,000 with \$150,000 of that earmarked to the 7 clinics run by John Hopkins/All Children's Hospital. The balance goes to the other 7 various clinics. This means we need to raise \$339,500 to cover our commitment to the clinics plus the minimal necessary expenses.

The fiscal year just ended on June 30, 2020. While it sounds pretty good that the Foundation hit 92.6% of its goal, the reality is that we were short almost 7.5% which is \$24,991 that we couldn't give to the clinics. The Valley of Tampa had a goal of \$79,759 which we just beat by 5%. However, the reason we were able to meet our goal was due to some bequests left to the Foundation from our deceased Brothers and families, otherwise we would not have made it.

I'd like to thank all of those who have given in the past and especially thank you for continuing your support in the future. Our commitment to the children is ongoing. Our pledge as a Valley, and as individual members of the Scottish Rite, is ongoing. Our Valley's goal for this fiscal year, July 1, 2020 -

June 30, 2021, is just over \$80,000. Everyone is encouraged to help in any way possible.

Some ways you can help:

1. Leave a bequest in your will for either a specific amount or the "remainder" of your estate after all of your named beneficiaries' bequests have been satisfied. (NOTE: If you do not have a Florida will or it has been years since it has been updated you are advised to see a qualified advisor for information about wills).
2. Ask a corporation to make a donation to the Scottish Rite Foundation of Florida, a 501(c)3 non profit charity. Most large corporations are very generous about helping local charities.
3. Support the direct mail campaign (if you don't take the free gift, it helps the Foundation).
4. Log onto: www.smile.Amazon.com to set up The Scottish Rite Foundation of FLORIDA as your chosen charity at Amazon for you and your friends. There is no cost to you and the Foundation will get .5% of the sales price of your purchases. Encourage everyone to do it.
5. Come along on a Scottish Rite Foundation cruise with your friends, family, and Brothers.
6. There is a line on your dues bill for an optional donation to the Foundation - add what you can.

The Feast of Tishri

The Scottish Rite Bodies, Valley of Tampa will celebrate the Feast of Tishri on Monday, October 12. Dinner will be served beginning at 5:45 p.m. in the Banquet Hall with the Program to follow in the Lodge Room, presented by Brother Steven Silvers, 32° KCCH.

The Book of Leviticus tells us that the Feast of Tishri (also known as the Feast of the Tabernacle and/or The Feast of Succoth) was started when God commanded Moses that "... in the fifteenth day of the seventh month, when ye shall have gathered in the fruit of the land, ye shall keep a feast unto the Lord seven days." Thus it was originally a harvest or gathering festival, and a time to give thanks.

This feast was still held in the time of King Solomon to the extent that he timed the dedication of the Temple to coincide with it. As Scottish Rite Masons, it is considered an obligatory observance under the Statutes of the Supreme Council, as a sharing of our fraternal spirit, and a reaffirmation of our dedication to the principles of the Scottish Rite. 🐾

7. We will soon take delivery of some brand new Scottish Rite Foundation coins (like challenge coins) which will be sold for \$20 each (+ S&H if mailed.) At this time the coins are in limited supply, so order soon through Ill. Drewett 33°, General Secretary.

8. Mail a check to the office in Tampa, or present it at a Consistory meeting
9. Ask your family to request, upon your passing, that donations be made to the SRF in lieu of flowers
10. If you are a Major Donor, proudly wear your Major Donor lapel pin, everywhere. It may start a discussion which will let you talk about the Foundation.

Speaking of recognition, donors who are Scottish Rite members can earn some Double Eagle points each year for making a donation to the SRF. Members AND NON MEMBERS can also gain Major Donor recognition for reaching different levels of total lifetime giving to the Foundation. Recognition includes (for members) Double Eagle Bars, (for members and non members, the following) different lapel pins depending upon level reached, and a nameplate on the Major Donor plaques in the lobby. Again, there are different plaques depending upon level of lifetime donations. Recognition starts at only \$1,000 in cumulative lifetime donations.

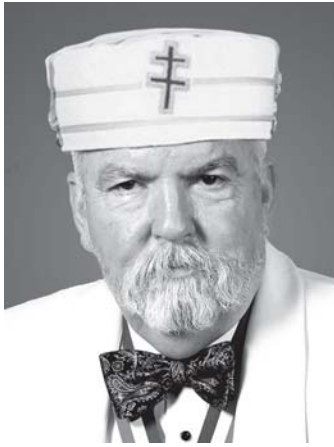

As a 501(c)3 non profit charity, the Scottish Rite Foundation is a perfect choice for those individuals over the age of 70 1/2 who are required to make annual disbursements from their individual IRA accounts. It is most definitely a WIN-WIN opportunity for the Foundation and the individual who by law needs to make an annual disbursement.

Please note that 97 cents out of every dollar donated goes directly to the programs at the clinics to help the kids. That means that the Scottish Rite Foundation's total expenses is only 3%. If you'll check with other charities you will see that is a remarkable achievement!

Oh, my! And how dissatisfying it is for our Lodges to go dark, Reunions to be shortened or cancelled and any number of Masonic events to be postponed or rescheduled because of the circumstances associated with the current pandemic in our society. There are less frequent opportunities to “dwell” together.

We entered the Fraternity hearing, early on, the question “what came you here to do?” We still have to answer that question for ourselves. The inability to (and perhaps inadvisability of) attending Lodge and other Masonic functions does not absolve us of our duty to answer the question.

Our search for Further Light is not limited to our physical presence at a meeting. Indeed, attending the numerous activities on the Masonic calendar may deceive us into believing we’re actually becoming enlightened or wise. We can all admit that sometimes our attendance is just going through the motions.

Such attendance may, indeed, help, aid and assist our growth; however, in our current environment, perhaps we should turn our attention and focus on personal individual action, study and education.

While we’re on “leave” from attending organized activities, we can direct our attention and energy to self-study and self-education.

In the Symbolic Lodge, the Florida Monitor is worthy of study. For example, the installation of officers helps us understand the opening and closing of the Lodge that we hear and recite so frequently; it

reminds us that each Officer’s duties are, in reality, our duties, whether we have the title or not. We can learn all the Charges: the opening and closing and the three degrees’ charges. We can study the monitorial portions of the Lectures.

In the Scottish Rite, a valuable tool is Bridge to Light, which summarizes and comments on all the Degrees. The Monitor and Guide takes our study to another level. The Master Craftsmen educational programs offered by the Supreme Council can be pursued.

We can do such things in our own homes and maskless. When we re-engage in the world, we’ll be better prepared to contribute to the Fraternity and our communities.

All Masons have their own personal challenges during the pandemic: personal, family, civic, spiritual, vocational and Masonic.

But the pandemic does not absolve us of our duty to become better men, husbands, fathers, citizens and brothers. The pandemic just alters how we expend our energies to attain further light, to improve ourselves and contribute to the betterment of society.

Let us resolve to continue these pursuits, whatever the circumstances.

The 25th Degree, Knight of the Brazen Serpent, will be conferred at the December 14 Consistory meeting at 6:10 p.m. 🙏

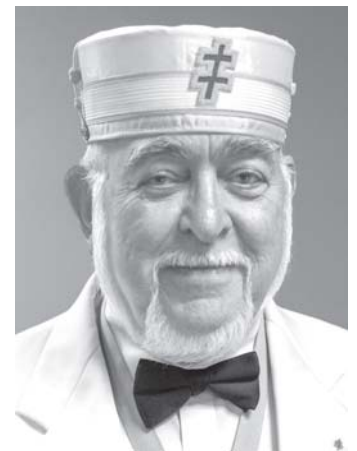
