

# Member Education & Director of Work

The Hiramic Legend is the foundation of the Fraternity's ritual and narrative. It is more than an entertaining story, it is a teaching device, as most legends and myths

are. And it is indeed a legend. In the Volume of Sacred Law, Hiram the Artificer completes his work and fades into the sunset.

The events of the second section of the Master Mason Degree were the creation of our ancient brethren to teach us something, to frame our conduct and character, and to make us think. The fact that the Hiramic legend is an interesting tale simply facilitates its use as a teaching device.

As a candidate, we represented Hiram Abiff in the third degree. We do so again in the Scottish Rite's fifth degree, Perfect Master. The fifth degree is (generally) an annual commemoration of Hiram's funeral ceremony.

Having twice represented the Grand Master early in our Masonic journey, it is worthwhile to consider what the message may be. The third degree instructs us that we are to "imitate this good man ..." It is one brief sentence. What does it mean?

Albert Pike, in *Morals and Dogma*, posits "Whatever Hiram really was, he is the type, perhaps an imaginary type, to us, of humanity in its highest phase, an exemplar of what man may and should become, in the course of ages, in his progress toward the realization of his destiny, an individual gifted with a glorious intellect, a noble soul, a fine organization, and a perfectly balanced moral being..."

This is still only one sentence of instruction. But it further frames the purpose of our Masonic journey. Hiram, a legendary "perfect master," is our example, our role model. We are to develop and emulate his "legendary" qualities.

The fourth degree, Secret Master, where we metaphorically passed from the square to the compasses, raised the bar for our conduct. The fifth degree raises it higher still. We are to emulate the Perfect Master of the Hiramic Legend. It is a tall order and high standard—but this is what we come here to do.

The annual commemoration of Hiram's funeral in the fifth degree, Perfect Master, offers many lessons. But foremost, it reminds us of our duty and purpose.

James 5:16 "The prayer of a righteous man is powerful and effective." (NIV)

Prayer, my Brothers, is the most powerful tool we have. At our Lodge meetings and our Consistory

meetings, we always have a report on sickness and distress, which is either followed by prayer; or, we are admonished by the Worship Master to pray individually for, he tells us, our prayers are effective in bringing about good results. AMEN to that!

But, we are told by James that it is the prayer of a "righteous" man that is powerful and effective. Yet, the Apostle Paul tells us in Romans that, "there is no one righteous, not even one; there is no one who understands, no one who seeks God, ..., there is no one who does good, not even one." (Romans 3:10-11, NIV). The Psalmist also spoke of this in Psalm 14:3, "there is none who does good, not even one." (NIV). So, do we just stop praying? ABSOLUTELY NOT! What are we to do?

The answer lies again in the same verses from Romans: Romans 3:11 "... no one who seeks God." God is the answer to all of life's problems. He is the author and finisher of our faith. God, Himself, gives us the answer through His Apostle John. In 1 John 1:9, he tells us, "If we confess our sins, He is faithful and just and will forgive us our sins and purify us from all unrighteousness."

We have a loving Father in Heaven who wants only the best for us. All He asks is that we believe in Him and put our faith in Him. Scripture tells us that Abraham believed in God and it was credited to him as righteousness. To be a righteous man and provide powerful and effective prayer, we must first humble ourselves before God, acknowledging Him as the Creator and Sustainer of all life. We must then confess that we, as humans, are sinful and only He can cleanse us and restore us to righteousness. Then, and only then, can we go to Him with our prayers and expect them to be answered according to His will.



Prayer is the most powerful and effective weapon we have against the ills of this world. But, it must be done correctly—in accordance with the template that God Himself has laid down for us. Acknowledging God for who He is, thanking Him for the good and the bad in our lives, confessing our sinfulness and asking for forgiveness, then petitioning Him for our needs. Simple, but the order is very important. God wants to answer our prayers; but, as a Holy God, He cannot abide sin, so we must rid ourselves of it before He will listen to our petitions. And isn't it GREAT that all we need do is confess and "He is faithful and just to forgive us?"

Pray continually my Brothers, pray hard, but pray properly. Peace be with you.
