#### Scottish Rite Foundation of Florida

The Scottish Rite Foundation of Florida helps children with learning disabilities by supporting 15 clinics located throughout the entire state of Florida. It depends upon donations made by corporations and individuals, most of whom are members of the Scottish Rite, their families, or friends.

The current annual commitment made to these clinics is \$250,000 with \$100,000 of that earmarked to the 7 clinics run by John Hopkins/All Children's Hospital. The balance goes to the other 8 various clinics. This means we need to raise \$269,500 to cover our commitment to the clinics plus the minimal necessary expenses.

The fiscal year just ended on June 30, 2022. Our Valley of Tampa managed to achieve 101% of our \$85,000 goal. We were able to meet our goal due to some bequests left to the Foundation from our deceased Brothers and families.

I'd like to thank all of those who have given in the past and especially thank you for continuing your support in the future. Our commitment to the children is ongoing. Our pledge as a Valley, and as individual members of the Scottish Rite, is ongoing. Our Valley's goal for this fiscal year, July 1, 2022 - June 30, 2023, is \$85,000. Everyone is encouraged to help in any way possible.

#### Some ways you can help:

Leave a bequest in your will for either a specific amount or the "remainder" of your estate after all of

your named beneficiaries' bequests have been satisfied. (NOTE: If you do not have a Florida Will or it has been years since it has been updated you are advised to see a qualified advisor for information about Wills).

Ask a corporation to make a donation to the Scottish Rite Foundation of Florida, a 501(c)3 non profit charity. Most large corporations are very generous about helping local charities.

Support the direct mail campaign (if you don't take the free gift, it helps the Foundation).

Log onto: smile.Amazon.com to set up The Scottish Rite Foundation of FLORIDA as your chosen charity at Amazon for you and your friends. There is no cost to you and the Foundation will get .5% of the sales price of your purchases. Encourage everyone to do it.

There is a line on your dues bill for an optional donation to the Foundation—add what you can.

Mail a check to the office in Tampa, or present it at a monthly Consistory meeting

Ask your family to request, upon your passing, that donations be made to the SRF in lieu of flowers

If you are a Major Donor, proudly wear your Major Donor lapel pin, everywhere. It may start a discussion which will let you talk about the Foundation.

### August Update - Building Project

We continue to make progress on the new facility! As we have vacated our current facility, the new 25,000 square foot facility has begun design and is

nearing completion of its schematic design phase. This phase is when the design professional and the owner develop the formalized concept of what the building should look like. The next phase will be to begin construction level design drawings for use in constructing the new facility.

The new building will be a three story, two floor complex: the offices, banquet hall, kitchen and associated areas on the first floor; and the lodge, board room, auditorium and associated areas on the second. The building is intended to be roughly 12,500 square


feet on each floor. The design currently incorporates Masonic elements into it such as a 3, 5, and 7-step frontage stair entry, 33 windows into the lodge room and other aspects to highlight the Masonic nature of the building. We intend for all brothers to be able to tell a Masonic story just by walking a fellow Mason up to the front of the building.

Currently the project is awaiting the finalization of the re-zoning process to begin demolition and preparation of the property for new construction. The next step in that process is a public meeting to discuss the potential rezoning with the community. This is currently set for September 19, 2022 at the Robert W Saunders Sr. Public Library on 1505 N Nebraska Ave in Tampa. It is set for 6:00 p.m., but is subject to change. Scottish Rite Masons are requested to attend to show support for the rezoning and the redevelopment of the property.

It is our hope to continue to move forward with the building design over the next few months and prep for construction in 2023. If you have any questions, or would like to offer any suggests, feel free to reach out to me at chasjordan@hotmail.com

## Member Education & Director of Work

The Fall Reunion is scheduled for November 12 and 19. The location is still to be determined. The format of the Reunion will differ from our usual theatrical confer-

ral of certain degrees and communication of others.

The Reunion will take the form of an education presentation. Commencing with the usual history and explanations about the Scottish Rite, the first day will review each of the Degrees of the Lodge of Perfection and the Chapter of Rose Croix. The second day will review the Council and Consistory Degrees and will conclude with a summary of basic lessons and a discussion of our roles and duties as Scottish Rite Masons.

The presentation will be aided by, and modeled upon, an approved Supreme Council syllabus developed for use when in-person reunions were inadvisable due to public health concerns.

Although passwords and other esoteric matters will be omitted, the format will qualify candidates as 32nd Degree Masons. All obligations will be administered by our Sovereign Grand Inspector General, Most Worshipful Richard Hoover 33°.

The candidates will be receiving the Degrees in the same manner as did Albert Pike. Albert Mackey communicated the Degrees to Pike, explained their respective lessons and obligated Pike as a Master of the Royal Secret. The theatrical mode of instruction now used did not then exist and commenced after Pike's death. So, this format is a return to an earlier tradition.

This Reunion format affords a valuable educational opportunity to existing members of the Valley. The presentation will journey through all 29 Degrees in sequence, exploring each's plot, lessons, and symbols, and the relationship with preceding and succeeding degrees. Members are encouraged to attend with pen and paper in hand. Bringing "Bridge to Light" to follow along is recommended.

Speaking of recognition, donors who are Scottish Rite members can earn some Double Eagle points each year for making a donation to the SRF. Members AND NON MEMBERS can also gain Major Donor recognition for reaching different levels of total lifetime giving to the Foundation. Recognition includes (for members) double eagle bars, (for members & non members, the following) different lapel pins depending upon level reached, and a nameplate on the Major Donor plaques in the lobby. Again, there are different plaques depending upon level of lifetime donations. Recognition starts at only \$1,000 in cumulative life-time donations.

This is our Foundation, yours and mine. When we joined the Scottish Rite we joined a marvelous organization with benefits including wonderful fellowship and great Masonic education, but we also inherited a responsibility to support our foundation to the best of our ability.

Please note: our foundation is the Scottish Rite Foundation of FLORIDA. There are many other Scottish Rite Foundations, but as members in FLORIDA, we want to help the kids in FLORIDA.

As a 501(c)3 non profit charity, the Scottish Rite Foundation is a perfect choice for those individuals over the age of 70 1/2 who are required to make annual disbursements from their individual IRA accounts. It is most definitely a WIN-WIN opportunity for the Foundation and the individual who by law needs to make an annual disbursement.

Please note that 97 cents out of every dollar donated goes directly to the programs at the clinics to help the kids. That means that the Scottish Rite Foundation's total expenses is only 3%. If you'll check with other charities you will see that is a remarkable achievement!

#### **Prelate**

Leviticus 11:44, "For I am the Lord your God. Consecrate yourselves therefore, and be holy, for I am Holy."

Wait, what? God wants us to be holy like He is? How can we be like God?



We are just humans and, well, He is God. That is exactly what God wants us to do—be just like Him! I don't mean omniscient or omnipresent; we are only humans. But He does want us to be holy—notice the little h. Holy is the Greek word αγιοσ—to be set apart, consecrated to the service of God. Sounds like being a Mason to me.

As Masons, we are called upon to set ourselves apart from the everyday culture. We walk, or try to, a morally straighter path. We are not to be influenced by the fads of the day, but remain true to our causewhich is to be better men. This is why our three pillars are Wisdom, Strength, and Beauty. Wisdom guides us to not be like the world, being tossed to and fro by every new idea or thought that is popular today then changes as the whims of people change. It takes Strength to not go along and be part of the crowd. To be your own person in the face of unsurmountable peer pressure takes all the strength we can muster. But when we prevail, Beauty shines brightly before all men; the beauty of righteousness. Not to be lorded over those that haven't found our light, but humble righteousness that says "follow me and I will show you a better way." Colossians 3:12 says "Put on then, as God's chosen ones, holy and beloved, compassionate hearts, kindness, humility, meekness, and patience." In other words, be a true Mason.
