Grand Master M∴W∴ Glen Bennett Bishop of the Grand Lodge F&AM of the State of Florida

M∴W∴ Glen Bennett Bishop was born on January 24, 1969 at Bayfront Hospital in St Petersburg, Florida. He graduated Northeast High School

in 1988 and enlisted in the United States Marine Corps in 1989, serving from 1989 to 1999. After graduating from Parris Island, his first duty station was MCAS Cherry Point, NC where he was deployed for the First Gulf War, a Mediterranean Float and to MCAS Iwakuni, Japan. During the next three years he was stationed in Fort Lauderdale Florida and promoted to the rank of E-5 or Sergeant where he served as an A Billet on Recruiting duty where he received a Navy/Marine Corps Achievement Medal. In his last three years of service, he was stationed at MCB Camp Pendleton where he severed on the General Staff where he was

again promoted, this time to E-6 or Staff Sergeant.

During this tour of duty, he received a 2nd Navy/
Marine Corps Achievement Medal and a Navy/
Marine Corps Commendation Medal. It was at this
duty station where he chose not to re-enlist and was

Honorably Discharged in 1999. During his tenure with the Marine Corps, M∴W∴ Bishop attended Park University where he obtained a BS in Management Computer Information

ment Computer Information Systems. Additionally, he attended Non-Commissioned Officer (NCO) Leadership School, Staff Non-Commissioned Officer (Staff NCO) Leadership School, and Department of Defense - Systems Administrator School.

Returning to his family in Pinellas County Florida, M∴W∴ Bishop put his Information Technology education to work as a Network Administrator and then further into Project Engineering, where he currently practices today. It was in 1983, when he first met the love of his life Odessa Lee McCabe and then reconnecting again in 2015 thereby finding his true love proposed marriage on Valentine's



Member Education & Director of Work

This column has often cited *On Obligations* (sometimes called *On Moral Duties*) by Marcus Cicero (106-43 BCE), a Roman statesman. This classic piece of literature

is a letter of advice from a father to son.

In *On Obligations*, Cicero wrote extensively on the topic of virtue. He told his son that virtue is centered upon three elements. The first lies in discerning what is true and genuine in a particular instance—understanding origins, consequences and causes. His son must be able to distinguish reality from appearance, assertion from argument. This first element is wisdom or prudence.

The second is the restraint of mental faculties, what the Greeks called emotion or passion. Virtue subjects human impulses to the control of reason. This element is temperance.

The third "enables us to treat our associates in a restrained and expert way," dealing with each other with consideration. This third element is justice, as Masons espouse, "to render to every man his just due without distinction."

Cicero further provided his son with two contrasting concepts of charity familiar to Masons.

He first offers a narrow application: "...our munificence should take account of men's worth... we are to assess the character of the recipient of our kindness." This sounds very much like an element of the obligations in the 2nd and 3rd Degrees and a declaration in the 14th Degree, Perfect Elu. This concept dispenses charity commensurate with worthiness.

But several paragraphs later Cicero counsels his son, "...our greatest obligation...is to lend help above all to the person in greatest need." This advice reminds us of one of the principal steps of Jacob's ladder in the Entered Apprentice Degree, to the great Law espoused in the 18th Degree, Knight of Rose Croix, and to an examination in the 31st Degree, Inspector Inquisitor. This concept of charity broadens our duty to include all humankind.

If *On Obligations* reads like a Masonic syllabus, perhaps it is. Our ancient Brethren probably read it and transmitted its lessons "unimpaired" to us within our Work. Albert Pike certainly read it; many of its passages are found in Morals and Dogma.

Cicero provided wise counsel to his son—and for us.

Drawing from the wisdom of the sages of antiquity, our ancient brethren have provided instruction in our ritual and lectures about what kind of men we should be or become, and what we should do, or not do; they transmitted to us many lessons on virtue.

We probably cannot think about that too much.

tice Mason in May 2006, Passed to the Degree of Fellowcraft in June 2006 and Raised to the Sublime Degree of Master Mason in September 2006. M∴W∴ Bishop is a 32° Scottish Rite Mason in the Valley of Tampa and has been invested a Knight Commander of the Court of Honor. He is also a member of Egypt Shriners, Selama Grotto, Clearwater York Rite Bodies, Queen Ester Chapter No. 4, Order of the Eastern Star and the Royal Order of Scotland.

M∴W∴ Bishop was elected to the station of Junior Grand Warden on May 28, 2020; Senior Grand Warden on June 2, 2021; Deputy Grand Master on June 1, 2022; and installed Most Worshipful Grand Master on May 31, 2023.

Prelate

Psalm 139:13-14
"For you formed my inward parts; you knitted me together in my mother's womb. I praise you, for I am fearfully and wonderfully made."



We, as Masons, are called to friendship, morality, and brotherly love. The Worshipful Master greets a new Brother by extending the hand of fellowship and brotherly love. But how do we find this Brotherly Love that we are supposed to exhibit? We find it by valuing our Brothers.

Before we can "value" our Brothers, we must first come to understand our own value. You cannot impart value to others if you don't first recognize your own value. Most of us probably think that is easy. Look at the job I have, the money I make, the house I live in, the car that I drive, or the Masonic title I hold. Those are all nice things, but in the end that is all they are-things. They hold no real meaning. When we are buried, what do we have? NOTHING! Except one thing—if we have professed our faith in God, we are God's children. That is where our true value comes from—from God Himself. We are valuable because we are children of God. We need to accept the fact that apart from God we are nothing. It doesn't matter what we have or what title we hold, if we have not God, we have nothing and we are nothing. John **15:5** says, "I am the vine; you are the branches. Whoever abides in me and I in him, he it is that bears much fruit, for apart from Me you can do nothing." Apart from God, we have no value; but, with Him and in Him we are invaluable. We need to recognize that our true value comes from our relationship with God; and, from that recognition we can attribute true value to our Brothers.

Genesis 1:27 tells us, "So God created man in His own image, in the image of God He created him; male and female He created them." Again, in Genesis 2:7 we see, "then the Lord God formed the man of dust from the ground and breathed into his nostrils the breath of life, and the man became a living creature."

We value our Brothers by remembering that they too are children of God. Made in His image. We need not look at all their outward, and human, accomplishments to see their value. We need to look at the man—fearfully and wonderfully made, with the very breath of God inside him. In our Entered Apprentice Degree lecture, we are informed the candidate is clothed in the garb of the lodge because it is the inward man we are concerned with, not outward appearances.

My Brothers, look at the Brothers around you, and see the light of God shining through them. Then, and only then, will Brotherly Love shine through.
