Building Project Update

My brothers, here we come into the final quarter of 2023, and I feel heavy with the fact that this project has not moved forward as we had hoped and planned. As many of

you know by now, we have been informed by our development partner, The Onicx Group, that the original proposal and development agreement terms that we entered, would no longer work for the development of our property and construction of our new temple. This was a personal body blow to me; due to the time I and the Valley office and executive staff have committed over the past two years to seeing this project be a success. When Rusty asked me to work on this project with him, I knew that the road to completion would not be a straight or easy one, but to have to start from the beginning again was not something I expected.

This summer, after this notification was given, and the added information that the value that could come from the development was much less than originally agreed upon, I recommended to the Temple Association, the Executive Committee, and the SGIG that we needed to move back into our existing facility and seek alternative options. Thank you to those brothers, and to the Valley in general, for agreeing with those recommendations.

So where do we go from here? I will say, that while this was a huge speed bump, that is all that it is. We already have multiple parties interested in discussing the purchase or development of our property in similar or new agreement terms than those we found favorable with Onicx. I am very optimistic that this may mean an even better situation for us, than the one we previously agreed to. That being said, that process will again take time, and we will probably be back in our existing building for a while again, which I am personally happy to see us home to continue to grow our Valley.

As we move forward, it is my goal that as we continue this project, we meet the financial expectations of the Valley in completing this deal, that we

can stay in our facility until we can move into a new one, instead of using a secondary location, and that we can move into a facility our Valley can truly be proud of. This probably means we will need to move to a different property location, which based upon the experiences we had during this process, is probably best for our Valley anyway.

I look forward to continuing to move this project forward (even if I am losing hair by the year with it now) and I sincerely hope my brothers of the Valley of Tampa accepts my apologies for this inconvenience, and continues to trust I will do my utmost to guarantee our Valley has a great home for many years to come.



Member Education & Director of Work

Masonic presentations at our Consistory meetings this year have included a series of three programs examining the 9th, 10th, and 11th Degrees, named Elus of 9, 15, and 12,

respectively. In these degrees, the role and symbolism of the Ruffians is addressed. The Blue Lodge deals with the Ruffians in the second section of the Master Mason Degree. The Scottish Rite does so in these three degrees.

Their plots plainly present a tale of crime and punishment, but our ancient brethren probably did not offer them for their entertainment value—hidden within are allegories and symbols that require thought and reflection. Action is encouraged on our part.

The 9th Degree deals with Jubelum. Parts of it can be troubling to the discerning mind. It seems to be about retribution and vengeance—not Justice. However, a deeper look reveals that he symbolizes our ignorance. Pike observed that "Ignorance, symbolized by Jubelum ... is the principal enemy of human freedom. It is ... to be everywhere smitten with the ... dagger of Truth."

In other interpretations, Jubelum represents Tyranny.

The 10th Degree, Elu of the 15, continues the saga with the apprehension of the other two Ruffians, Jubela and Jubelo. These assassins symbolize our ambition and fanaticism.

Taken together, the three ruffians are the chief enemies of freedom. Ignorance impedes, ambition denies, and fanaticism imposes. To this list of vices, other commentators add intolerance.

The degrees also offer political ideas. A free press is alluded to in the 9th. The 9th and 10th Degrees together suggest a government should possess an upper and lower house of legislators. The 11th Degree highlights an independent judiciary and espouses the right of trial by jury—a right that, Pike asserts, is more important than the right to vote.

Weaving together the symbolism of the Ruffians with the political ideas, it appears implausible that any form(s) of government will achieve liberty,

equality and fraternity in the face of ignorance, unbridled ambition, intolerance and fanaticism. This reminds us that *individual* virtue, morality and character matter.

There is much more to ponder in these three degrees; many metaphors, visual symbols, allegories, numerology, mystical ideas, religious references ... continued study will reveal lessons of value.

We all have some ruffian in us. Perhaps, what we learn from the ruffians and glean from the political narrative of the 9th through the 11th Degrees is: individual conduct and action matter. What we do matters to us and our communities. Who we are matters, too. These three degrees are a call for our individual action.

At a future meeting, the 12th Degree, Master Architect will be examined.

Reclaiming the Soul of Freemasonry

The Supreme Council of the Scottish Rite Northern Masonic Jurisdiction (NMJ) commissioned the most comprehensive, data-driven analysis of the Scottish Rite and Freemasonry in more than 20 years. The results of that study are outlined by former Sovereign Grand Commander John Wm. McNaughton in his seminal work, *Reclaiming the Soul of Freemasonry*. The book forms the strategy that will guide the Scottish Rite as our fraternity creates new resources for members, completely revamps its use of technology, and inspires all Brothers to feel deep pride in the organization.

"According to the data, we can be sure, finally, that this is not an organization out of step with society. In fact, trends point to the opportunity for a renewed interest and period of growth." – John Wm. McNaughton, Past Grand Commander NMJ

To design and execute this research, the Supreme Council (NMJ) worked with Cercone Brown Company (CBC), an independent research and marketing firm with national and international clients, specializing in mission-based organizations. Surveys were conducted on two groups:

Group I: Scottish Rite Membership

To better understand member retention and satisfac-

tion, The member survey was offered to more than 24,000 Scottish Rite Masons throughout the 15-state Northern Masonic Jurisdiction. More than 3,000 members responded.

Group II: Non-Masons

A second survey was developed and administered to 1,000 men across the United States (ages 21-65.) This phase of research allowed us to better understand American men today and inform member recruitment by gauging interest in the values and lifestyle of the Scottish Rite and Freemasonry.
