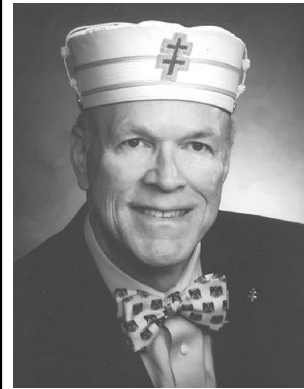

### Are We Jonah's?

*Jonah 1:1-3 "Now the Word of the Lord came to Jonah, the son of Amittai, saying, 'Arise, go to Nineveh, that great city, and call out against it, for their evil has come up before me.' But Jonah rose to flee to Tarshish from the presence of the Lord. He went down to Joppa and found a ship going to Tarshish. So he paid the fare and went on board, to go with them to Tarshish, away from the presence of the Lord."*

Jonah hated the Ninevites because they were not "God's chosen people". He thought God was only for the Jews. He had self-righteous indignation for the Ninevites to the point that he ran from the job God had called him to do. He would rather die than share God with anyone not Hebrew.

God calls all of us to do some work. Do we listen to His voice, or do we run as fast and as hard as we can away from what God is calling us to do? We know what is right and what is wrong; we know when we shouldn't do something because it is foolish or possibly dangerous, but we do it anyway. We do what we want because we want it, not really thinking about the consequences to us or others. How often in our lives have we made decisions that seemed a good idea at that time but down the road turned out disastrous? If we think on those times, did we hear that still, small voice urging us to go a different direction, but we ignored it. That's what we do because we are all self-centered to some degree. That was Jonah's problem as well.

God wants what is best for us. When He calls us to some action, it is to bring a blessing to others, but, even more, it is to bless us. How much joy do WE get when we help others. That is what God wants for all of us, to live in joy and the peace that surpasses all understanding. We just finished a terrible time with two hurricanes; and, we had the opportunity to go out and help each other to put our lives back together. How did that make you feel—as the helper or the one helped?

God pursued Jonah on his sea journey, then into the fish, and finally all the way to Ninevah. Why? Because He wanted to bless the Ninevites after they heard His message from Jonah and repented of their evil ways; and He wanted to bless Jonah by having him be a part of God's great plan. We are all children of God and as such we are all ministers for God throughout the world. That ministry may be your workplace, your family, your lodge or your group of friends. Be faithful to God's calling on your life and enjoy the full blessings, joy, and peace that comes from a gracious and faithful God.

We are approaching the 2025 JROTC/ROTC Award Season.

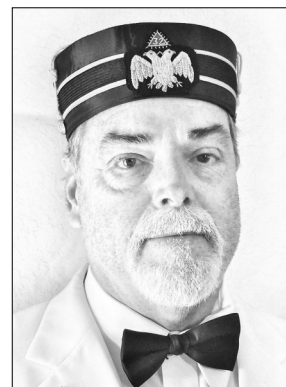

**JOHN N. DRAGNEFF, 32°**

**MASTER OF KADOSH  
TAMPA CONSISTORY**

R.:W.: John Dragneff was born and raised in Tampa, Florida and graduated from H. B. Plant High School. In April of 1982, he married his high school sweetheart, Rachael Cohalla Dragneff. In 1982, he started working in corporate security and was with various companies over the years. In 1986, John started his own business, Tampa Alarm Company. John attended Tampa College, earning a Degree in Criminal Justice, later pursuing a Degree in Business Administration at Florida Metropolitan University. In 1993 he started with the Pasco Hernando Community College Law Enforcement Academy and finally realized his life-long dream of following in his forefathers' footsteps, joining the Pasco County Sheriff's office in 1994.



He was quickly promoted to Detective, working in gang intelligence and narcotics. He was the liaison detective with the Tampa Bay Area Gang Intelligence Task Force (MAGTAF). During his 14-year career, John served on the Hostage Rescue Team as a hostage negotiator, worked in patrol as a Field Training Officer, and in Community Policing/Street Crimes as a Supervisor. His career ended prematurely when he suffered a debilitating injury forcing retirement.

John joined the US Navy Reserves in 1999, serving as a Gunner's Mate Second Class, assigned to Assault Craft Unit 1 out of Coronado, California, where he served as a Lead Petty Officer for the Unit, Training Officer, and Unit Career Counselor. After retirement, John & his wife went back into entrepreneurship starting their own business in the oversized trucking industry. He now enjoys retirement on his cattle ranch with his grandchildren.

His Masonic career started at Trilby Masonic Lodge No. 141 when he was initiated on January 1, 2005, Passed January 29, 2005, and Raised February 12, 2005. He served as WM in 2009 & 2016, selected as District Deputy in 2019, and served as an Appointed Grand Lodge Officer in 2021. He also served as Zone Chairman for Membership Development and on the Jurisprudence Committee. He is also a member of the following allied and appendant bodies: Royal Order of Scotland, Maxwell Clan, Egypt Temple Shrine, Zenda Grotto, Founding Monarch of Zara Grotto, Masters & Wardens – Dist. 14, York Rite Plant City Chapter No. 16 Royal Arch Masons, Tyler Council No. 4 Royal & Select Masters, Plant City Commandry No. 6 Knights Templar, and Order of the Eastern Star Crescent Chapter.

R.:W.: Gregory Wynn was born on March 21, 1963, at Schilling Air Force Base in Salina, Kansas. R.:W.: Wynn has lived in Hillsborough County since 1965. He is a 1981 graduate of Brandon Senior High School and graduated from the University of South Florida with a Bachelor's Degree in Criminology. There he joined the Lambda Chi Alpha fraternity, and

serves on the Alumni Advisory Board to their Chapter at the University of Tampa.

During his high school and early college years, R.:W.: Wynn worked in retail sales. He worked up from a part-timer to store manager of a Discount Auto Parts store. His strong service orientation and desire to contribute to the well being of others prompted him to investigate a career in law enforcement. In 1987, he became a Deputy Sheriff with the Hillsborough County Sheriff's Office. In 1990, he was assigned as a School Resource Officer and routinely promoted safety by challenging high school students to always wear their seatbelts. Following a campaign with near perfect compliance by student drivers, he allowed them to shave his head with the slogan, "Buckle Up, because you never know when you're going to have a close shave." He received several commendations and awards, most notably a national award as School Resource Officer of the Year (1999). Additionally, he made several school safety presentations at crime prevention conferences nationwide and also volunteered for Camp Anytown, a youth leadership camp sponsored by the NCCJ. He was promoted to Corporal in 2004. In 2007, he began supervising traffic enforcement deputies: DUI officers, Traffic Crash Investigators, and Motormen. R.:W.: Gregory Wynn retired from the Hillsborough County Sheriff's Office in 2017.

It was at the Brandon Assembly of God picnic in 1979, that R.:W.: Wynn was introduced to Theresa Ann Custer. They began socializing at church youth group functions, dating occasionally, then more frequently, and were married on April 20, 1985. They have two sons: Carlton born in 1988; Matthew born in 1991. R.:W.: Wynn and Lady Theresa's family has added two wonderful daughters-in-law and three beautiful grandchildren.

R.:W.: Gregory Wynn was Initiated an Entered Apprentice, Passed to the Degree of Fellowcraft, and Raised to the Sublime Degree of Master Mason in February 2007, at DeSoto Lodge No. 105 F&AM in Riverview, FL. He served as its Worshipful Master in 2011. He was appointed District Instructor in 2013 and 2014. In May of 2016, he was appointed District Deputy Grand Master for the (old) 23<sup>rd</sup> Masonic District by M.:W.: Stanley L. Hudson. He was appointed Grand Tyler in 2019. In 2020, he was appointed Grand Representative to The Grand Lodge of Scotland. R.:W.: Wynn has served on the Penal Affairs Panel for several years, being the Vice Chairman in 2017 and State Chairman in 2019, 2020, and 2021. He was also the State Chairman for Child ID in 2022 and 2023. R.:W.: Wynn is a 32<sup>nd</sup> Degree Scottish Rite Mason in the Valley of Tampa and was invested a Knight Commander of the Court of Honor on November 9, 2019.
