


MEMBER EDUCATION & DIRECTOR OF WORK

M:W: Donald W. Cowart was born in Gainesville, Florida. He spent his formable years growing up in Alachua County. He attended elementary, junior, and high school in Gainesville. He moved to Brandon, Florida in the summer of 1966. While living in Brandon, he attended Brandon High School. He graduated from Brandon in June of 1969. He attended Hillsborough Community College for two years.

In September of 1969 he started a 41 year career with General Telephone and Electronics. He was a Cable Splicer for about 3 to 4 years, before being promoted to Management as an Outside Plant Construction Manager. He retired in November of 2010. M:W: Cowart is married to Lady Dell.

M∴W∴ Cowart received the Three Symbolic Degrees of Freemasonry as a member of Temple Terrace Lodge No. 330 in Temple Terrace, Florida in 1978. He demitted to Brandon Lodge No. 114 in 2007. He served his Lodge as Worshipful Master in 2013. He was elected as Secretary of his Lodge for six consecutive years. He served his District in various chairmanships from 2013 through 2016.

He served as District Deputy Grand Master for M : W : Stephen P. Boring in 2015. He was appointed W : Senior Grand Steward in 2017 by M : W : Richard G. Hoover, and was appointed by M : W : John W. Westerman III as his Grand Marshal in 2019 as well as a member of the Corporate Board. He has also served on the Jurisprudence Committee for 3 years and served on various Grand Lodge Committees in the following capacities: State Chairman for Grand Master Coin Sales in 2017 and 2018, Zone Chairman Membership Development in 2014, Zone Chairman Grand Masters Charity in 2016, and District Chairman Membership Development in 2017. M : W : Cowart received from M : W : Richard G. Hoover the Lifetime Appointment of being the Grand Representative of the Grand Orient Do Brazil.

Jack opens with the simple observation "A good Masonic ritualist does not necessarily make a good Mason." On the other hand, "a good Mason does not necessarily make a good ritualist... someone with a deep knowledge of Freemasonry might barely be able to string together a sentence on the floor of a lodge".

Notwithstanding this observation, a proficient delivery, by memory, of masonic work can leave a lasting impression and impart valuable lessons both to the candidate and the brethren on the sidelines. Ritual is how we convey the lessons of masonry. It is how we teach and learn.

A larger point discussed by Jack is that "the whole purpose of Masonic teaching was to imprint the lessons offered into the minds of the workmen, whereby it became habitual. Today one might refer to the process of "muscle memory" ... intended for the self-improvement of both individuals and society at large."

A word appearing in the Entered Apprentice lecture makes this point – inculcate. To inculcate is to instill an idea, attitude, or habit by persistent instruction and repetition.

Upon learning the ritual, one repeats it over and over again until it is committed to memory. Such is prerequisite to proficient delivery. But again, the larger point is that the memorization inculcates the ritual's lessons upon both the ritualist *and* the brethren on the sidelines who, though they may never deliver the work, listen to it over and over again.

Inculcating the lessons of the work to form good habits seems to be what we're after. Memorization, historically, seems to be the proven vehicle for accomplishing this aim.

Paraphrasing Jack, through memorization and repetition, the teachings and lessons of masonic work become inherent in us; we do not simply remember them, they become an essential part of our being.

Let us resolve to regularly study and learn our work, remembering that our objective is not necessarily to proficiently confer it in open Lodge, but to memorize its lessons into the "muscle memory" of our hearts and behavior.—See you in Lodge.

John 17:13-17 (NIV)

¹³"I am coming to you now, but I say these things while I am still <u>in</u> the world, so that they may have the full measure of my joy within them. ¹⁴I have given them your word and the world has hated them, for they are not <u>of</u> the world any more than I am <u>of</u> the world. ¹⁵My prayer is not that you take them out <u>of</u> the world but that you protect them from the evil one. ¹⁶They are not <u>of</u> the world, even as I am not <u>of</u> it. ¹⁷Sanctify them by the truth, your word is truth."

Note that I have underlined the words in and of. What we are being told is to be "in" the world, but not "of" the world. Wait, what?? How can this be? It is really quite simple. We were all born into this world of a woman; but, when we put our faith in God, we were reborn of the Spirit. The Spirit of God—not of this world. So we are now not "of this world" IF WE CHOOSE SO! And this choice must be made intentionally and daily. As in the above passage of Scripture, we have been given God's word as a guide to our faith and practice. And God's word is the Truth. However, if we choose to follow God's word and His truth, we go against virtually everything in the world today.

We are constantly being bombarded with all kinds of information from all different sources—each one telling what we should believe. Each person or group has their own agenda and twist the facts-or only give you part of the story- to suit their own purposes so that you will think like them. We are told we should buy bigger and better because that is the only way to happiness—how's that working out for you? As we head into the Fall elections, we are drowning in political commentary-each side telling us to believe. All of this is just pulling us back to be "of the world". And let me just say, There is little to no truth in any of it! We don't want to be "of the world", we want to be of God. The Scriptures tell us how to do that. That is why we call it a Great Light.

Most of us are familiar with Deuteronomy 6:4, known as the Shema, "Hear, O Israel: The Lord our God, the Lord is One. You shall love the Lord your God with all your heart and with all your soul and with all your might." This is how to be "of God". Our only protection from all that the world throws at us is our deep, abiding faith in God. Want to know who to vote for in the next election—ask God in prayer. Want to know if you need to spend your money on bigger and better, what do the Scriptures tell us? John 8:31-32 tells us, "If you abide in my word, you are truly my disciples, and you will know the truth, and the truth will set you free." This is the promise of Scripture-The Word is Truth, and it will guide you through all the darkness that is the world—IF YOU LET IT!
