COMMANDER COUNCIL OF KADOSH

Brother Joseph A. Severino was born on March 22, 1942, in Quincey Massachusetts. At the tender age of one (1) year old, he moved to Tampa, Florida, residing here his entire life. He graduated from Jesuit High School in 1960, later earning an

Associate of Arts Degree from Hillsborough Community College. Brother Severino gathered many stories between 1965 and 1978 working for the Tampa Police Department. He authored a book recounting some of these adventures in "Halt Sucker! A TPD Corporal's Official Memoirs." Following his retirement, he worked as a Unit Manager for the Caspers Company, a Supervisor for City of Tampa 911 Communications Center, and in the service department for Lazy Days RV Supercenter.

Brother Joseph Severino was initiated an Entered Apprentice, April 5, 1984; passed to the Degree of Fellowcraft, June 13, 1984, and raised to the Sublime Degree of Master Mason on September 6, 1984, within A.W. Windhorst Lodge No. 185. He served his Lodge as Worshipful Master in 1990 and again in 2015. He was appointed District Instructor for the 20th Masonic District in 2019; the following year he was appointed District Deputy Grand Master by Most Worshipful Tommy Turlington, Grand Master. He has served as second and first vice president, then president of the Hillsborough County Masters & Wardens Association. He organized three (3) outdoor degrees and headed up two (2) DDGM fundraiser "roasts," both very successful. Brother Severino remains active in his Blue Lodge, Shriner of Egypt Temple, and Zenda Grotto.



VENERABLE MASTER LODGE OF PERFECTION

M:W: Glen Bennett Bishop was born on January 24, 1969, at Bayfront Hospital in St. Petersburg, Florida. He graduated Northeast High School in 1988 and enlisted in the United States Marine Corps in 1989, serving from 1989 to 1999.

After graduating from Parris Island, his first duty station was MCAS Cherry Point, NC, where he was deployed for the First Gulf War, a Mediterranean Float, and to MCAS Iwakuni, Japan. During the next three years he was stationed in Fort Lauderdale, Florida, and promoted to the rank of E-5 or Sergeant where he served as an A Billet on Recruiting duty where he received a Navy/Marine Corps Achievement Medal. In his last three years of service, he was stationed at MCB Camp Pendleton where he served on the General Staff where he was again promoted, this time to E-6 or Staff Sergeant. During this tour of duty, he received a 2nd Navy/Marine Corps Achievement Medal and a Navy/Marine Corps Commendation Medal. It was at this duty station where he chose not to re-enlist and was Honorably Discharged in 1999. During his tenure with the Marine Corps, M:W: Bishop attended Park University where he obtained a BS in Management Computer Information Systems. Additionally, he attended Non-Commissioned Officer (NCO) Leadership School, Staff Non-Commissioned Officer (Staff NCO) Leadership School, and Department of Defense – Systems Administrator School.

Returning to his family in Pinellas County, Florida, M:W: Bishop put his Information Technology education to work as a Network Administrator and then further into Project Engineering, where he currently practices today. It was in 1983, when he first met the love of his life Odessa Lee McCabe and then reconnecting again in 2015, thereby finding his true love, proposed marriage on Valentine's Day in 2020, with a small private ceremony held on January 21, 2021.

In 2006, M:W: Bishop petitioned Clearwater Lodge No. 127 and was Initiated an Entered Apprentice Mason in May of 2006, Passed to the Degree of Fellow Craft in June 2006, and Raised to the Sublime Degree of Master Mason in September of 2006. He has served as Worshipful Master of Clearwater No. 127 in 2010 and in 2016. M:W: Bishop has served our Grand Lodge in various District and Zone Committees as well as on the Masonic Home Board of Trustees and the Corporate Board. In May of 2013, he was appointed District Deputy Grand Master for the 20th Masonic District by M:W: Danny R. Griffith. M:W: Stanley L. Hudson appointed him as District Instructor in 2016. M:W: Richard G. Hoover appointed him as W: Grand Marshal in 2017 and presented him with the John P. Duval Award in 2018. Also in 2018, he was appointed Grand Representative to The Grand Lodge of State Baja California.

M∴W∴ Bishop is a 32nd Degree Scottish Rite Mason in the Valley of Tampa and has been invested a Knight Commander of the Court of Honor on November 13, 2021. He is also a member of Egypt Shriners; Selama Grotto; Clearwater York Rite Bodies; Queen Ester Chapter No. 4, Order of the Eastern Star; and the Royal Order of Scotland.

M∴W∴ Bishop was elected to the station of Junior Grand Warden on May 27, 2020; Senior Grand Warden on June 2, 2021; Deputy Grand Master on June 1, 2022; and installed Most Worshipful Grand Master on May 31,

MEMBER EDUCATION & DIRECTOR OF WORK

Casey A. Fletcher, 33°

The allegory of Freemasonry, the building of Solomon's Temple described in the Winding Stairs lecture, continues into the Scottish Rite. The Fellow Craft and many Scottish Rite degrees draw on portions of the Volume of Sacred Law that describe the Temple.

Perfection. We mourn and commemorate the death of our Grand Master in the 4th and 5th Degrees. The relationship of Solomon and Hiram of Tyre is examined in the 6th Degree. The 7th Degree addresses personnel issues among the Craft. Workmen are selected to continue the Grand Master's work in the 8th Degree. Justice is dispensed to the Ruffians, albeit differently than in the Symbolic Lodge, in the 9th through 11th Degrees. Steadily each degree becomes an "enigma to be solved, not a lesson to be read" or heard. A picture develops. It is a picture teaching us that we are not workmen learning to build a material edifice, but men trying to build our character. We have not been using the operative mason's working tools to become proficient craftsmen or skilled workmen; we have been examining them as symbols of what it might mean to be a good, decent human being. We learn "each man has a character of his own choosing." We have been toiling thus far so that we might choose well.

Through the 11th Degree the Masonic narrative employs a building motif. In 12th Degree, Master Architect, something changes. The building motif winds down. The Hiramic Legend runs its course having served its purpose. This is a transition degree in the Rite.

Heretofore, our attention has been directed toward demonstrating proper conduct, continuing education, controlling passions, attaining knowledge, exemplifying virtue, and cultivating morality. The 12th Degree suggests that all this preparation, all these endeavors, have had as their aim the pursuit of wisdom.

Our focus is redirected from earthly matters, from the "realm of morality," virtue, and action toward the arenas of philosophy and wisdom. We learn, perhaps, that "what we came here to do," is to be concerned with the nature of reality, the Universe and philosophia, the love of wisdom. Our quest for further light, we learn, is clearly a quest for wisdom.

The instructions of the 12th Degree are largely derived from the Book of Proverbs and other Scriptures and speak to broad issues of life, wisdom, and philosophy. We leave the quarry behind. The allegory of the first Temple is left behind also. The building motif in our narrative ceases and is replaced with a "wisdom motif." The ritual of this Degree paints a clearer picture of what "in search of further light" might mean.

The 12th Degree, Master Architect, will be examined in an upcoming program at the Tri-County Scottish Rite Club on March 27 in Lake Wales.

PRELATE

You have heard it said, "You will know the truth and the truth shall set you free". This is from John 8:32. I will tell you a truth that will surely set you free. But, the required action from this truth is probably the hardest thing that you will ever do in your life. This truth comes from the Lord's Prayer in Matthew 6: 12, "and forgive us our debts, as we also have forgiven our debtors." (ESV). Forgiveness! That is what will set you free. Most of us hold grudges to some extent or another. Perhaps

even from childhood, you remember that one person that did you wrong and you swore you would never forgive them. Perhaps a family member or another brother from your lodge caused you pain in some way, but in harmony you have kept it bottled inside of you. This leads to anger and possibly hate which will eat you up from the inside. In the Ten Commandments, we are taught "Thou shalt not commit murder", Exodus 20:13. In Matthew 5:21, we are told that anyone who is angry with his brother has committed murder in his heart. Forgiveness is so important, we are instructed from Matthew 5:23-24, "So if you are offering your gift at the altar and there remember that your brother has something against you, leave your gift there before the altar and go. First be reconciled to your brother, and then come and offer your gift."

We all have egos and we all like to have things the way we think they should be. And, when that doesn't happen we take offense. But most of us just keep it inside and let it stew, slowly becoming bigger and bigger, as our mind adds to the mix other perceived slights until finally, one day, we explode over the tiniest nit. And, the target of our explosion probably has no idea what they did to cause this drastic reaction. Then they too get angry and the whole scenario begins anew. But what if, at the first little thing, we forgive them. Know this—forgiveness isn't for them, it is for us. You don't even have to tell the person you forgive them—you have to forgive them in your heart and let the anger die inside you. Should you talk out your issues with the person who you think offended you—absolutely. Chances are they don't even know they offended you. Reconcile with them as Scripture says, and forgive them in your heart. Then you may be healed.

Most of us like to hold onto our grudges. We have been offended in some way and by holding onto our grudge we feel we have power over that person. In reality the only thing we have over them is resentment. Most people don't intentionally offend others and, unless you tell them, they don't even know. They just see you pulling away in some fashion and they wonder what is the matter with you—it couldn't be anything I did. Unforgiveness breaks apart relationships. That anger you are holding onto goes to your very core, and eventually it will erupt like Vesuvius. But forgiveness builds relationships—it sets you free to be loving and kind. See what I did there?

Forgiveness sets you free from hate and anger and malice. It frees you to love and be loved. Matthew 22:37-39, "You shall love the Lord your God with all your heart and with all your soul and with all your mind. This is the first and greatest Commandment. And a second is like it: You shall love your neighbor as yourself." When you can free your heart, then you can be truly free.
